


KARNATAKA STATE BUDGET 2022-23



BUDGET OVERVIEW

- Budget estimate (Consolidated Fund) Rs.2,65,720 crore.
- Total receipts Rs.2,61,977 crore; Revenue receipts Rs.1,89,888 crore; Public debt – Rs.72,000 crore and Capital receipts – Rs.72,089 crore.
- Total expenditure Rs.2,65,720 crore; Revenue expenditure-Rs.2,04,587 crore; Capital expenditure – Rs.46,955 crore and Loan repayment – Rs.14,179 crore.
- Allocation made for different Sectors:
 - 1. Agriculture and Allied Activities Rs.33,700 crore.
 - 2. Welfare and Inclusive Growth Rs.68,479 crore
 - 3. Stimulating Economic Growth Rs.55,657 crore.
 - 4. Comprehensive Development of Bengaluru Rs.8,409 crore.
 - Conservation of Culture, Heritage and Natural Resources Rs.3,102 crore.
 - Administrative Reforms and Public Service Delivery Rs.56,170 crore.
- Allocation of grants for Children Welfare in the Budget Rs.40,944 crore. (Child Budget)
- Allocation of grants for SCSP / TSP Rs.28,234 crore. Increase over previous year is Rs.2,229 crore.

 Additional allocation of grants for Health, Education, Skill Development and other Welfare programmes – Rs. 6,329 crore.



NEW SCHEMES FOR THE YEAR 2022-23:

Priority for Increasing the Income of Farmers:

- New scheme "Raitha Shakthi" to encourage use of Farm machinery by giving diesel subsidy of Rs.250 per acre; Grant of Rs.600 crore.
- Rs.50 crore for post-harvest management and export promotion through KAPPEC.
- Establishment of "Mini Food Parks" on PPP model in all districts of the State.
- Establishment of Modern cold storage facility for storage, conservation and transportation of grapes at Toravi in Vijayapura district at a cost of Rs.35 crore and transportation of grapes through Cold storage transportation vehicles.
- 33 lakh farmers, including 3 lakh new farmers, will be distributed loan of Rs.24,000 crore under interest subsidy scheme.

Farm Production Enhancement and Farmers' Welfare:

• Re-introduction of "Yashashwini" scheme to provide medical facilities to rural farmers. A grant of Rs.300 crore from State Government.

- Establishment of Mega milk dairy in Haveri district; Constitution of separate District Milk Unions for Shivamogga, Chikkamagaluru, Davanagere-Chitradurga districts.
- Insurance of Rs.5 lakh to the families of sheep / goat rearers and migratory shepherds in case of accidental death.
- Implementation of "Mathsya Siri" scheme to encourage deep sea fishing by giving assistance of 100 Deep Sea Fishing Boats in convergence with Prime Minister's "Mathsya Sampada" scheme.

Priority to Irrigation:



- Allocation of grant for major irrigation projects in the State: o Upper Krishna Project 3rd Stage – Rs.5,000 crore. o Kalasa and Banduri Nala Diversion project – Rs.1,000 crore. o Upper Bhadra project – Rs.3,000 crore. o Yettinahole project – Rs.3,000 crore. o Mekedatu project – Rs.1,000 crore.
- Grant of Rs.1,000 crore for construction of balancing reservoir near Navale to compensate deficit in the storage of water in Tungabhadra Reservoir.
- Action to include Sannatti lift irrigation project and Upper Krishna project Stage 1 & 2 – Boodihala, Peerapura, Nandavadagi, Narayanapura right bank (9A) extension canal under the Central Government PMKSY-AIBP.
- Irrigation facility to 35,319 hectares by completing 14 Irrigation projects which are under progress.
- Action to formulate plan for new irrigation projects at estimated cost of Rs.8,774 crore already approved in the year 2021-22.

- Development of Micro clusters of leather toys in Chikkaballapur, embroidery in Dharwad, kowdi and kinhala toys in Koppal, agarbathi in Mysuru, carpets in Navalgunda, toys in Channapatna and sarees in Ilakal, Guledagudda, Shidlaghatta, Molakalmuru and Belagavi-Shahapur with a target to augment income, business, employment and exports.

- Action to provide training in self-defence to 3 lakh girls in the State.
- Rs.800 crore outlay to various development corporations under SC/ST welfare departments.
- Enhancement of monthly pension payable to unmarried and divorced women and gender minorities from Rs.600 to Rs.800. 1.32 lakh beneficiaries will be benefited.
- Monthly pension payable to women victims of acid attack is enhanced to Rs.10,000.
- Enhancement of monthly pension by Rs.1,000 to wrestlers of over 50 years of age.






