





About the Philosopher

Nelson Mandela was a South African politician and activist. On April 27, 1994, he was made the first President of South Africa elected in a fully represented democratic election. He was also the first black President of his country, South Africa.

His government focused on throwing out the legacy of apartheid by ending racism, poverty, inequality, and on improving racial understanding in South Africa.

Politically a believer in socialism, he served as the President of the African National Congress (ANC) from 1991 to 1997 and adopted new Constitution of South African in 1996 that prohibits all discrimination, based on language, religion, handicap and sexual orientation, not only on racism. Internationally, Mandela was the Secretary General of the Non-Aligned Movement from 1998 to 1999.

Mandela died on 5 December 2013 in Houghton Estate, Johannesburg from a respiratory tract infection. He was 95 years old.

ICAI, Mangaluru to host two-day national conference 'Parijnana' from June 7 to 8

Mangaluru, June 3: The ICAI Mangaluru Branch is all set to host a two-day national conference 'Parijnana' at Dr. T. M. A Pai International Convention Centre here on the June 7 and 8. The Institute of Chartered Accountants of India(ICAI) is a statutory body, established by an Act of Parliament for regulating the profession of chartered accountancy in the country. The event would comprise of 6 sessions, where experts from distant places would be present.

The 'Parijnana' event would witness some exceptional speakers imparting knowledge on various subjects. State minister of energy, and Kannada and Culture V Sunil Kumar will be the chief guest. Other delegates attending event are ICAI South India Regional Council chairman and chartered accountant China Masthan T. and Dakshina Kannada, MP Nalin Kumar Kateel.

The event will host six technical sessions, where about 750 CAs. They exclaimed that this was indeed a proud moment for them as the delegates from far and wide were also expected.

During the press release, chairman, Mangaluru branch of SIRC, ICAI, Prasanna Shenoy M said that more than 4000 students had applied for the CA Course. When asked about the CA classes to be given in the nearby areas, he replied that initially, the prime focus would be towards the southern regions, where the best teaching experience would be provided to the students at minimal cost.

Chartered accountants Prasanna Shenoy, Gautham Nayak M, vice chairman, Gautham Pai D, secretary, Prashanth Pai, treasurer, Daniel Pereira, SICASA chairman and Mamta Rao, member were presnt at the press meet.

Mangaluru, Jun 7: The two-day national conference 'PARIJNANA' hosted by Mangaluru branch of ICAI was inaugurated at TMA Pai convention centre on Tuesday June 7 under the aegis of professional development committee of ICA.

CA Prasanna Shenoy, chairman Mangaluru branch of SIRC of ICAI said that the role of Chartered Accountants was crucial in serving the economy and contributes towards nation building. He informed that 'PARIJNANA' implied knowing the unknown. Further, he added that the two-day programme would be graced by the presence of various notable experts, who would impart knowledge on various subjects.

















Addressing the gathering, chairman of the southern India regional council of ICAI, CA Chinna Masthan hinted that there were quite many upcoming events and conferences in the day. He spoke about the training programme for students, which would be free of cost. He informed about the various aspects regarding Chartered Accounting.

Addressing the gathering, conference director Kota Srinivas indicated that the various measures such as merging of banks, further led to the reduction of number of banks. He informed that the CAs are the global leaders, who would serve not only their home country, but also abroad. "The idea is to stay local and serve global, where any given CA can provide service to the foreign countries, from their place work." Further, he spoke about the newly added benefits such as an increase an increase in the stipend, new awaiting opportunities and many others. He also informed about a residential course for students, at a reasonable cost of Rs 12,000.

MLA Mangaluru South Vedavyas Kamath said, "The ICAI has organized several programmes, be it debates, discussions and many others. All these events were organized to impart knowledge in this particular field." He regarded the CAs to be the backbone of the country's economy and the bridge between the people and the country and thereby contributing to nation building. He lauded the students who excelled in their 10th grade examinations.

CA Prasanna Shenoy, chairman Mangaluru branch of SIRC of ICAI welcomed the gathering. CA Geetha gave an outline of the proceedings and various sessions of the two-day programme. CA Gautham delivered the vote of thanks.

UPDATE CAPSULE

Amendments to Regulations/Rules/Act/Circular/Notification

CBDT notified amendment in Faceless penalty scheme, allowing mandatory personal hearing [Notification No. 54 Dated May 27, 2022]

The Central Board of Direct Taxes (CBDT) has notified the amendment in the faceless penalty scheme, allowing mandatory personal hearing through electronic mode to any taxpayer who has sought a hearing. The amendment has omitted the Regional Faceless Penalty Centre from the Faceless Penalty Scheme and provides that electronic records shall be authenticated by the National Faceless Penalty Centre and even hearing should be done via them and not regional faceless penalty centre.

The Faceless Penalty (Amendment) Scheme, 2022, notified says that such hearing will be held exclusively through video conferencing or video telephony, including use of any telecommunication application software which supports video conferencing or video telephony.

Clarification regarding Form No 10AC issued till the date of this Circular [Circular 11 Date June 3, 2022]

The Finance Act, 2022 has inserted amended provisions of the Income-tax Act allowing the Principal Commissioner or Commissioner of Income-tax to examine if there is any 'specified violation' by the trust or institution registered or provisionally registered. After examination, an order is required to be passed for either cancellation of the registration or refusal to cancel the registration.

In view of the amendments made vide Finance Act, 2022, the conditions subject to which the registration /approval or provisional registration / provisional approval was granted to trusts and institutions need to be revised to align the same with the amendments made by Finance Act, 2022. Thus, the Central Board of Direct Taxes (CBDT) has issued a circular clarifying that:

Conditions for grant of registration under sections 12AB, 10(23C), and 80G:

The Board has listed down the revised conditions that should be followed by the trust or institution seeking:

- Re-registration and provisional registration under section 12AB,
- Re-approval and provisional approval under section 10(23C), and
- Re-approval and provisional approval under section 80G

The conditions contained in Form No. 10AC, issued between 01.04.2021 till the date of issuance of Circular, i.e., 03-06-2022, shall be read as if the said conditions had been substituted with the conditions as provided by the board with effect from 1st April 2022.

Provisional registration / approval to be deemed as registration/approval: The Board has clarified that if due to technical glitches, Form No. 10AC has been issued during FY 2021-2022 with the heading "Order for provisional registration" or "Order for provisional approval" instead of "Order for registration" or "Order for approval", then all such Form No. 10AC shall be considered as an "Order for registration or approval".

Cost Inflation Index FY 2022-23 [Notification No. 62 Dated June 14, 2022]

Cost Inflation Index for Financial Year 2022-23 is **331** Notification No. 74 [Dated June 30, 2022]

The Central Government notifies following virtual digital assets which shall be excluded from the definition of virtual digital asset:

- Gift card or vouchers, being a record that may be used to obtain goods or services or a discount on goods or services;
- Mileage points, reward points or loyalty card, being a record given without direct monetary consideration under an award, reward, benefit, loyalty, incentive, rebate or promotional program that may be used or redeemed only to obtain goods or services or a discount on goods or services;
- Subscription to websites or platforms or application.

Notification No. 75 [Dated June 30, 2022]

The Central Government specifies a token which qualifies to be a virtual digital asset as non-fungible token within the meaning of subclause (a) of clause (47A) of section 2 of the Income tax Act, 1961 but shall not include a non-fungible token whose transfer results in transfer of ownership of underlying tangible asset and the transfer of ownership of such underlying tangible asset is legally enforceable
