

## **GENERAL KNOWLEDGE**

#### HISTORY OF NATIONAL CANCER AWARENESS DAY

National Cancer Awareness Day was first announced by the Indian Union Minister for Health and Family Welfare Dr. Harsh Vardhan in September 2014, and that 7th November will be observed as National Cancer Awareness Day every year to generate awareness about early detection and avoid leading cancer-causing lifestyles.

Dr. Harsh Vardhan launched a state-level of cancer control, encouraging early

detection and research into curina cancer. National Cancer Awareness Day also encourages people to report government hospitals, CGHS, and municipal clinics for а free screening. Information booklets are also circulated to aenerate awareness on how to avoid getting cancer and to look for signs of early symptoms. In 1975, the National Cancer Control Programme was



initiated to provide cancer treatment facilities in India. The program was modified in 1984-85 to provide thrust to prevention and early detection of cancer.

National Cancer Awareness Day is observed on 7th November to coincide with the birth anniversary of the Novel-prize winning scientist Madame Curie. Born in Warsaw, Poland in 1867, Marie Curie is remembered for her discovery of radium and polonium, and her huge contribution to the fight against cancer. Her work led to the development of nuclear energy and radiotherapy for the treatment of cancer.

In India, nearly 1.1 million new cases are being reported annually. It is estimated that one woman dies of cervical cancer every 8 minutes in India. Tobacco (smoked and smokeless) use accounted for 3,17,928 deaths in men and women in 2018. Cancers of the oral cavity and lungs account for over 25% of cancer deaths in males and cancer of the breast and oral cavity account for 25% of cancers in females. Today, Dr. Harsh Vardhan advises that if detected early, cancer could be treated at a fraction of the cost that is incurred when diagnosed at an advanced stage. Its mortality rate is also lowered substantially if people report for screening when the earliest symptoms are manifested.

#### ❖ DIRECT TAX

#### Direct Tax Collections for F.Y. 2022-23 up to 10.11.2022

The provisional figures of Direct Tax collections up to 10th November, 2022 continue to register steady growth. Direct Tax collections up to 10th November, 2022 show that gross collections are at Rs. 10.54 lakh crore which is 30.69% higher than the gross collections for the corresponding period of last year. Direct Tax collection, net of refunds, stands at Rs. 8.71 lakh crore which is 25.71% higher than the net collections for the corresponding period of last year. This collection is 61.31% of the total Budget Estimates of Direct Taxes for F.Y. 2022-23.

#### ❖ BANKING AND INSURANCE UPI transactions rise 7.7 per cent to 730 crore in October

Transactions through Unified Payments Interface (UPI) rose 7.7 per cent to 730 crore and the total value stood at more than Rs. 12.11 lakh crore in October. In September, there were 678 crore UPI-led digital transactions worth Rs. 11.16 lakh crore. The number of instant interbank fund transfer through IMPS (Immediate Payment Service) in October stood at 48.25 crore and the value was at Rs. 4.66 lakh crore.



## INTERNATIONAL BUSINESS NEWS Wheat export doubles to USD 1.48 bn in April-September

The country's wheat exports more than doubled to USD 1.48 billion during April-September 2022-23 as compared to the year-ago period, the commerce ministry said on Wednesday. The exports stood at USD 630 million in the year-ago period.





#### Karnataka Rajyotsava – 2022

The 67th Karnataka Rajyotsava is celebrated across the state in schools, institutions, associations, and government offices with joy and pride. The state flag is hoisted, processions are marched, and the day is celebrated this year in a more meaningful way.

The day is marked by the announcements and presentations of awards, hoisting of the official Karnatak flag across the state, along with community festivals, folk music and dance of Karnataka, Kannada book launches, and concerts.

The Karnataka Foundation Day or Karnataka day, the Kannada Rajyotsava is celebrated every year on 1st November. In 1956, the day came to reality when all the Kannada-speaking regions united to form one state, the State of Mysore which later was named Karnataka. The day is celebrated across the state with the vibrancy of the yellow and red colour state flag, in traditional attire, and with great enthusiasm.

#### Karnataka Ratna Award -on Kannada Rajyotsava Day

The day is also earmarked for honouring and felicitating extraordinary people from various fields and recognizing them for their achievements and contribution to society. This year 67 personalities will be awarded the prestigious Karnataka award. The Karnataka Ratna Award will be presented to Dr. Puneet Rajkumar posthumously, fans of whom adorable call him 'Appu'. Puneet Rajkumar, son of a famous Karnataka movie actor and an actor himself, has contributed a lot to society.

Other dignitaries like Former ISRO chairman K Sivan, actors Dattanna, Avinash, and Sihi Kahi Chandru will also be awarded Rajyotsava Award this year.

Soligara Madamma, credited for popularising cooperatives among the Soliga community, Saalumarada Ninganna (environmentalist), Yakshagana artiste Dr. M Prabhakar Joshi, retired IAS officer Madan Gopal, writers A R Mitra and professor Krishnegowda, differently-abled swimmer Raghavendra Anvekar among many others will also be awarded Kannada Rajyotsava in the year 2022.

#### Convoys

The state roads are filled with processions on bikes, cars, and walking bearing yellow and red colour state flags singing, dancing, and celebrating the state foundation with joy, pride, and enthusiasm. The bike and car rallies and processions with great zeal and enthusiasm by youngsters showcasing their love and affection towards the state are visible on the streets.

#### **Cultural Programmes**

No celebration is complete without colourful and vibrant dance, music, positivity, and grandeur. Various cultural programs across the state comprising of state folk and classical dance and music, performances in traditional attires, and Karnataka food specialties like Bisi Bele Bhat, Kesari Bhat, and Mysore Pak, are the essential and integral part of the celebration. Schools, colleges, associations, government offices, and various bodies collectively celebrate the day with great pomp and show.


#### Flag Hoisting

The state ceremony, held at Bangalore is either celebrated at Vidhana Soudha or the KAnteerva Stadium.
