The Institute of Chartered Accountants of India (ICAI) is a statutory body established by an Act of Parliament, viz. The Chartered Accountants Act, 1949 (Act No.XXXVIII of 1949) for regulating the profession of Chartered Accountancy in the country. The Institute, functions under the administrative control of the Ministry of Corporate Affairs, Government of India. The ICAI is the second largest professional body of Chartered Accountants in the world, with a strong tradition of service to the Indian economy in public interest.

The affairs of the ICAI are managed by a Council in accordance with the provisions of the Chartered Accountants Act, 1949 and the Chartered Accountants Regulations, 1988. The Council constitutes of 40 members of whom 32 are elected by the Chartered Accountants and remaining 8 are nominated by the Central Government generally representing the Comptroller and Auditor General of India, Securities and Exchange Board of India, Ministry of Corporate Affairs, Ministry of Finance and other stakeholders.

Over a period of time the ICAI has achieved recognition as a premier accounting body not only in the country but also globally, for maintaining highest standards in technical, ethical areas and for sustaining stringent examination and education standards. Since 1949, the profession has grown leaps and bounds in terms of members and student base.

PROFILE OF INAUGURATOR



CA Arun Singh
Honourable Member of Parliament

Arun Singh, an Indian politician and Chartered Accountant, was born on 4 April 1965 in the remote village of Baidha in the district of Mirzapur (U.P).

He is graduated in Commerce from Allahabad University in 1984 and qualified as a Chartered Accountant in 1988 with All India Ranking. He credits himself with not only an experience of 25 years as a Chartered Accountant, but also as a splendid academician. He has been a guest faculty in the discipline of management and finance, served as the Director of State Bank of India and Union Bank for seven years, worked as a consultant for projects of World Bank and United Nations and with several notable corporations.

He has been resolute in his commitment towards excellence in academics, which is evident from his devotion towards Dr. Shyama Prasad Mukherjee Research Institute, of which he is the current Secretary.

Arun Singh, being a renowned academician and politician is also BJP's in-charge of two states- Rajasthan and Karnataka. Earlier when he was in-charge of India's eastern state of Odisha his work and well-planned strategies helped party to strengthen its organisation more in Odisha, which also resulted into substantial surge in BJP's support base there.

Currently he is In-Charge of the BJP Headquarters. For the second time, the party's leadership is entrusted to Shri Singh with the responsibility of National General Secretary of the world's largest political party. Prior to this, he was the National Secretary and Co-Head of BJP's National Membership Programme where after Bhartiya Janata Party has become the world's largest party.



Shri. Arun Singh entered the public life when he joined the Rastriya Swayamsevak Sangh (RSS) and began to prove his merit while working with the Sampark Pramukh. His political career started with his becoming the leader of the Bharatiya Janata Yuva Morcha, the youth wing of the Bharatiya Janata Party. He assumed the office of Vice President and National Treasurer of the youth wing of BJP from 1999 to 2004 and became the National Convener of Investor Cell. He was the National Vice President BJYM for International Youth Convention. He was entrusted with the responsibility of managing Chhattisgarh in 2009 Lok Sabha elections and Jharkhand Vidhan Sabha elections.

In the meantime, he also served as the National Executive Member of BJP from 2009 to 2014. He was the State Co-Incharge (Prabhari) of Odisha BJP in the year 2013-14 and was later promoted to the post of State Incharge taking into account his diligence and efficiency. He has also been a member of the Team of Modi Campaign Committee, New Delhi, India. He served as the National Secretary of BJP from 16 August 2014 to 16 June 2015. He exhibited his hard work and ingenious skills as the National Co-Incharge for the membership drive wherein he not only directed the drive, he himself travelled throughout the country to make the campaign successful under the leadership of Shri Amit Shah. The successful campaign, to which his mature and competent leadership and his proficient work were significant, led to his promotion to the post of National General Secretary of BJP on 17 June 2015.

Mr. Singh, at present, is the Member of Parliament (Rajya Sabha) Uttar Pradesh, National General Secretary, In-Charge of the BJP Headquarters and member of the Office Modernisation Committee. He also leads the party's National Member Programme, which has made BJP world's largest party.

CA. Nihar N Jambusaria is the man of professional wisdom, vision and strong organisational skills with a firm belief in all round inclusive growth of Indian Chartered Accountancy profession. He has been elected as the new President of the Institute of Chartered Accountants of India (ICAI) for the year 2021-22 wherein he is currently serving for third consecutive term, i.e. 2013-16, 2016-19 and 2019-22.

A blend of erudition, experience, foresight, technical expertise, professional excellence worth emulating, and a Fellow Chartered Accountant from Mumbai, CA. Jambusaria, qualified as a Chartered Accountant in 1984 and was in practice for nearly 27 years. He has also served as Chairman of WIRC of ICAI in 2004-05.

CA. Jambusaria is now Chairman of all Standing Committees including Executive, Finance and Examination Committees, besides being the ex-officio member of all Non-Standing Committees and Editor of ICAI Journal, The Chartered Accountant. CA. Jambusaria is Director of ICAI Registered Valuers Organisation (RVO) and the representative from ICAI RVO on the "Committee to advice on Valuation matters". CA. Jambusaria is Chairman of the ICAI Research wing, ICAI – Accounting Research Foundation and Extensible Business Reporting Language (XBRL) India.

CA. Jambusaria is the member of Professional Accountants in Business (PAIB) Advisory Group of International Federation of Accountants (IFAC). He, in his capacity as President, ICAI would also be representing ICAI on International Integrated Reporting Council (IIRC) and the Board of South Asian Federation of Accountants (SAFA). He has also served as Member of SAFA Committee on Professional Accountants in Business (PAIB).



CA. Jambusaria is member of very important committees constituted by the government and regulators relating to policy formation that include Government Accounting Standards Advisory Board (GASAB) and Audit Advisory Board- both constituted by the C&AG of India. He is also Board Member, Insurance Regulatory & Development Authority (IRDA), Insurance Advisory Committee and Apex Committee of IRDA, and Member of SEBI's Primary Market Advisory Committee. The University Grants Commission (UGC) has also nominated him on the Review Committee for the B.Com (Hons) and B.Com New Syllabus for all the Universities in the Country. He was a Member of the e – Commerce Committee formed by the Ministry of Finance and Peer Review Committee of the Central Board of Direct Taxes.

An altruistic hard-worker bestowed with exceptional organisational, networking, administrative and leadership skills, CA. Jambusaria has made noteworthy contributions in whatever capacity he served the profession, particularly as the Chairman of – Ind AS Implementation Committee, International Tax Committee and various other important Committees/ Board of ICAI.

CA. Jambusaria has been a prolific speaker at national and international forum. As an academician and an orator par excellence, he has attended and contributed to numerous national and international seminars. 



NAMMA KUDLA- OUR PRIDE!

Our city Mangalore is named after the Goddess Shri Mangaladevi is also called as Mangaluru by the Kannadigas, Kodial by the Konkani speaking community and our neighbour state Keralians call it Mangalapuram. The place also got its name in Sanskrit as Manjarun and Kodeyaala in Havyakka. But it is “Mokedha Kudla” for all the Tuluvas. Legend says that the entire coastal belt ranging from Kasargod to Udupi is created by lord Parashurama. Mangaluru being located in the same coastal belt is also a part of “Parashurama Shristi”. The history of Mangaluru trails back to thousands of years and was ruled by the Mayura, Kadambas, Alupas and Sangama dynasty.

Mangaluru is the land which has kept its rich Culture, Tradition and Diversity intact along with adaptation to modernisation. The people have welcomed the new platforms in various fields but never let the culture get suppressed by the modern society. It's not only the place where you see huge buildings with Architectural uniqueness but also the place with lush green fields carrying out agricultural activities, fishing, handicrafts and other ancestral occupations.

Mangaluru is the home, which one will cherish when they leave for a distance place because they still remember the Traditional houses where joint families lived together happily ploughing the fields, growing crops, rearing animals, stocking hays, people working in the fields during the rain. Vegetables and Fruits hanging down the roof and the food stored for the monsoon days. The earthy smell of the first rain, getting drenched in the muddy fields and sitting cosy munching homemade snacks while the rain filled the rivers and lakes. Wooden cycle were the favourite toys, the art and craft of kids started from the coconut leaves, running around the Tulsi Plant and seeing that the Rangoli do not get spoiled when getting chased, watching plays one learnt many tales to tell. The fragrance of the jasmine in every function is commonly found. The fisherman gathering their boats and nets trapping fishes all day, spend their days together in far sea risking their lives amongst the waves. The richness of Tulunadu culture is more than the words could describe.

I. CULTURAL HERITAGE

The place has given birth to a number of diverse art and culture. Out of which the following have gained the prominent place in the lives of the people as well as fame in different parts of the world. Various association conducts different events to ensure that the culture and the tradition do not vanish over time.

Yakshagana- One of the iconic art, is a night-long dance and drama performance portraying various stories from the history or of the stories by various writers that combines dance, music, dialogue, costume, make-up, and stage techniques with a unique style and form. There are two subgenres of Yakshagana based on the region. ‘Badagu Thittu’ (belonging to northern part of Udupi and Uttara Kannada district) and ‘Tenku Thittu’ (belonging to Dakshina Kannada and other southern parts of Udupi district). The art is performed by various troupes (commonly known as Mela in Tulu) such as Kateel Mela, Pavanje Mela, Dharmasthala Mela, Hosnagara Mela, Bhagavathi Mela and many other. Devi Mahathme is the widely performed Yakshagana.





Talamaddale-Where the artists sit across in a place with the cultural attire and engage in testing their oratory skills based on the chosen story, which teaches the real value and the inner meaning of our history.

Pili Vesha-Young males form troupes of five to ten members or more, get painted and costumed to look like tigers (pili in tulu) perform to the beats of chende during Navaratri to honour the Goddess Durga whose favoured animal is tiger.



Kambala-The buffalo race is conducted in water filled fields where people watch it day and night with enthusiasm. The winning pair of buffaloes gets the Gold medal. The Kambala Jockey Shrinivas Gowda ran 142.5 metres in 13.62 seconds, which can be equated to completing 100 metres in 9.55 seconds, faster than world record held by international sprinter Usain Bolt with 9.58 seconds for the same distance. Within a week of this, a new record by another Kambala Jockey Nishant Shetty was made, breaking the record of Shrinivas Gowda, who took 9.51 seconds to complete the same. People for the Ethical Treatment of Animals (PETA) had opposed Kambala and tried to ban by filing a case against the same, calling it a cruelty on animals. But the Supreme Court passed the order against PETA permitted the Kambala festival to be conducted as earlier.

KoridhaKatta-It is a spiritual cockfight held at the Daivasthana after the yearly rituals. Hosting the same is usually banned but organised during the specific festival as part of religious or cultural event on seeking permission.

The Tradition of every Religion and Caste is practised with due respect and warmth. Temples, Churches and Mosque with great miracles and belief rest in the city and in the outskirts. Temple-Out of the countless temples in the city and in the vicinity, the most sacred ones are Shri Kudroli Gokarnath Temple, Shri Kadri Manjunatha Temple, Shri Mangaladevi Temple, Shri Kateel Durgaparameshwari Temple, Shri Sharavu Mahaganapathi Temple, Shri Polali Rajarajeshwari Temple and Shri Venkataramana Temple.

The Car festival of Shri Venkataramana Temple, commonly known as Kodial Theru is celebrated for five days ending with Holi on the sixth day, Mosarukudike (DahiHandi in Hindi) event conducted during the Krishna Janmastami, the Mangaluru Dasara organized by Kudroli Shri Gokarnanatheshwara Temple are the most awaited festivals every year. Ganesh Chaturthi and Nag Panchami are the festivals which are celebrated by almost all Hindu families. The Mangaluru Dasara is no less than the Mysore Dasara. During Navarathri the city decorated with lights, the procession on the 10th day of all Navadurgas along with idols of Sharada Devi and Mahaganapati are accompanied by PiliVesha, Chende, Tablo carrying artist who showcase different stories are watched by staying awake all night until morning till we get to see the last sight of Goddess Sharadhe during Visarjana (immersion in the temple lake).



It is the place that not only worship the Gods but also believe that the land and its people are protected by Daiva, Naga and people with divine power. Bootha Kola or spirit worship and Nagaradhane or Snake worship has equal belief similar to the presence of God. As per legend, this was the land where Serpents (*naagadevaru in Kannada*) stayed before Lord Parashurama threw his axe. As we are staying in the home land of the Serpents, we worship them with great devotion.

Mosque-The Ullala Dargah Hazrat Sayyid Muahammed Madani Darga and Juma Masjid, Noor Masjid, Zeenath Baksh Jumma Masjid, Manjanady Juma Masjidh, Ahsanul Masjid etc., are some of the mosques where muslim community offer their offerings.





Church-The St. Aloysius Chapel, Milagres Church, Infant Jesus Shrine, St. Joseph Vaz Shrine, St. Francis Xavier Church are some of the famous churches and the Catholic community celebrate their festivals such as Christmas, Nativity, Easter, Good Friday etc.

III. BEACHES



The major imports of the port are crude and petroleum products, LPG, wood pulp, timber logs, finished fertilizers, liquid ammonia, sand, phosphoric acid, other liquid chemicals and containerized cargo. It offers berth for cruise vessels as well.
